## Guaranteed Analysis

MAGNESIUM (Mg) .....	5.00%
SULFUR (S) (Combined) .....	10.00%
BORON (B).....	2.50%
MANGANESE (Mn) .....	10.00%

Derived from Sodium Borate, Magnesium Sulfate, Manganese Sulfate, Citric Acid, and Ethylenediaminetetraacetic Acid (EDTA) used as the chelating agent.

**APPLICATION:** Typical application rate is 2.5 pounds of BEAN-KICKER per acre applied as a foliar spray during the early vegetative stage (V-3 to V-6) of the plant. Additional applications may be made if signs of manganese deficiency are evident. Soil test results or tissue tests should be used as a base reference.

**DIRECTIONS FOR USE:** Add BEAN-KICKER to spray water first and allow to completely dissolve. Then add compatibility agents and finally add any additional products, allowing each to mix totally in the solution before adding the next. Bean-Kicker has been used in conjunction with herbicide spray solutions with excellent results. Caution must be used when mixing to diminish any negative effects on the herbicide efficacy.

**MIXING SEQUENCE MUST BE:** BEAN-KICKER first, Ammonium Sulfate or other compatibility agent, and lastly the herbicide. (Each product must be allowed to mix completely before the addition of the next.) Use a "jar test" to ensure compatibility.

**CAUTION:** THIS PRODUCT CONTAINS BORON, MAGNESIUM, AND MANGANESE. SHOULD BE USED AS RECOMMENDED. MISUSE MAY PROVE HARMFUL. DO NOT USE WITH DINITRO COMPOUNDS, DORMANT OIL, BORDEAUX, SPRAY LIME, OR HIGHLY ALKALINE SPRAY MATERIALS. ALWAYS ADD BEAN-KICKER TO SPRAY MIXTURE AS THE FIRST INGREDIENT AND DISSOLVE COMPLETELY.
